**Statutory Declaration**

**Section 31(6) of the Highways Act 1980**

I, Richard John Shaw, DO SOLEMNLY AND SINCERELY **DECLARE** as follows:

1. I am and have been since the 14<sup>th</sup> day of August, 1987, the owner of the land known as Jumble Head Farm, off Scammonden Road, Krumlin, Barkisland, Halifax HX4 0EP, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 17<sup>th</sup> day of February, 2011, I deposited with Calderdale Metropolitan Borough Council, being the appropriate Council, a statement accompanied by a plan delineating my property by red edging which stated that the ways coloured blue on the said plan had been dedicated as footpaths, and no other ways had been dedicated as highways over my property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 17<sup>th</sup> February 2011 referred to in paragraph 2 above and at the present time I have no intention of dedicating any more public rights of way over my property.
