# STATUTORY DECLARATION

## SECTION 31 (6) OF THE HIGHWAYS ACT 1980

1 Lovegrove-Fielden DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 25.3.1973 the owner of the land known as Dobroyd Estate

declaration since the statement dated 21 June 1997 referred to in 2. above [since the date

of the statutory declaration referred to in 3. above] [other than those (highways with vehicular  
status) (bridleways) (footpaths) marked in the appropriate colour on the plan accompanying this  
declaration] and at the present time no intention of dedicating any more public rights of way over  
my property.
