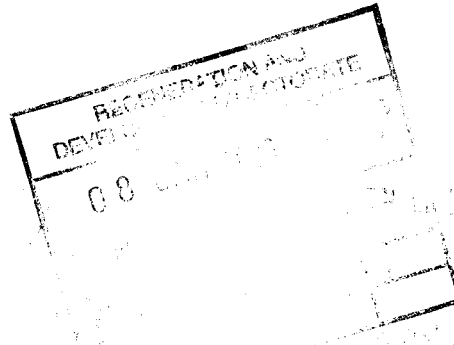

I/We understand that this statement will have effect for ten years and thereafter a Statutory Declaration will need to be lodged to afford continuing protection to the land. No reminder will be issued by the Council.

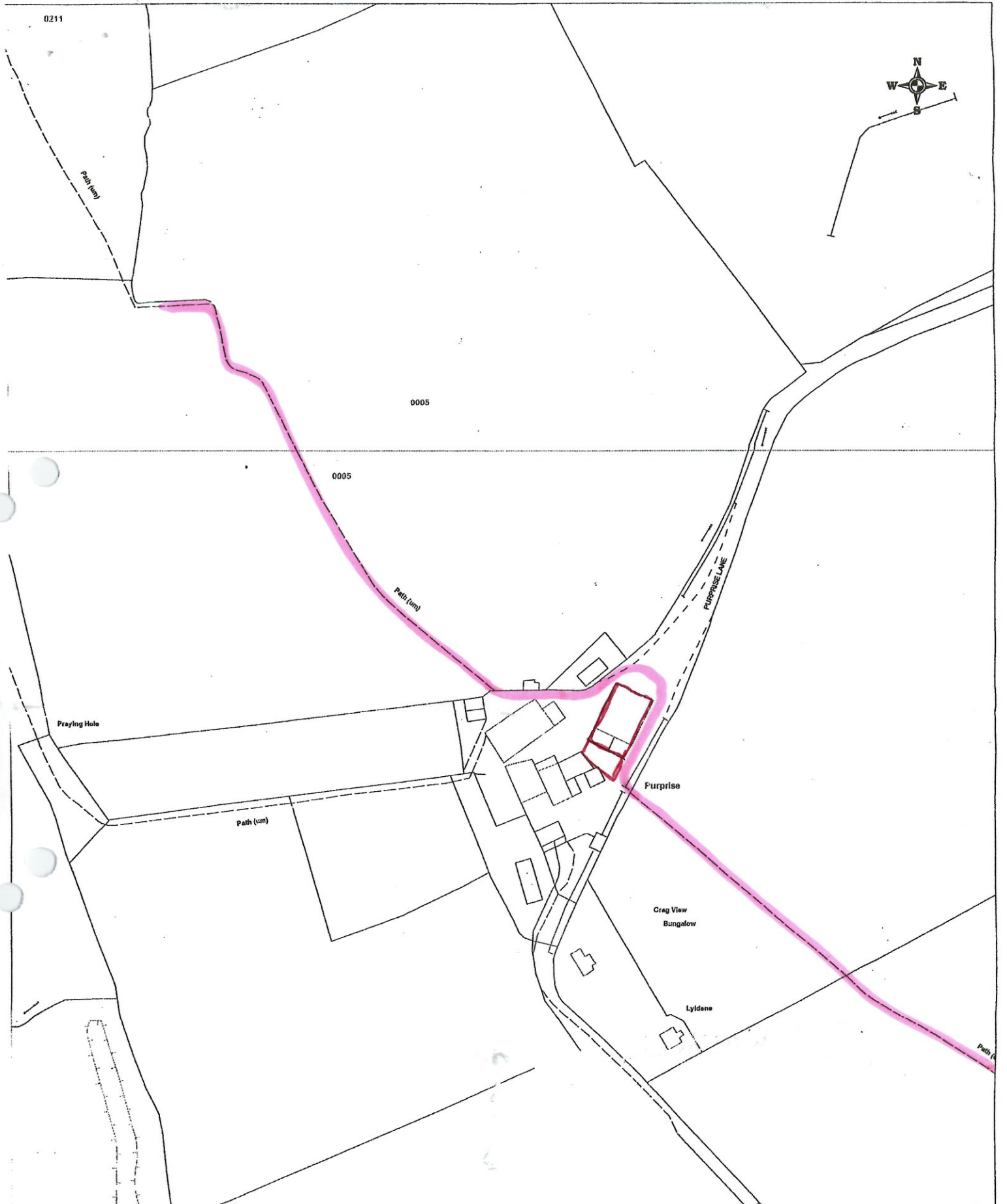
