### THE BOROUGH COUNCIL OF CALDERDALE (WAITING AND LOADING AND PARKING PLACES) (HALIFAX) (CONSOLIDATION) ORDER 2015 (VARIATION NO. \*) ORDER 20\*\*

The Borough Council of Calderdale in exercise of its powers under Section 1, 2, 4, 32, 35, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order (hereinafter referred to as "the Variation Order") to vary the Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2015.

- 1. This Variation Order is made the xx day of xxxx 20xx and may be cited as "the Borough Council of Calderdale (Waiting and Loading and Parking Places) (Halifax) (Consolidation) Order 2015 (Variation No.\*) Order 20\*\*" and will come into operation on [TBC].
- 2. The Borough Council of Calderdale (Waiting Loading and Parking Places) (Halifax) (Consolidation) Order 2015 (hereinafter referred to as "the Consolidation Order") shall be varied as follows:
  - i. The items in Table A to this Variation Order are to be added to Schedule 3.01 to the Consolidation Order.
  - ii. The items in Table B to this Variation Order are to be added to Schedule 5.01 to the Consolidation Order.
  - iii. The items in Table C to this Variation Order are added to Schedule 8.04 to the Consolidation Order.
  - iv. The items in Table D to this Variation Order are to be added to Schedule 8.06 to the Consolidation Order.
  - v. The items in Table E to this Variation Order are to be added to Schedule 14.10 to the Consolidation Order.
  - vi. Table F to this Variation Order is added to the Consolidation Order as Schedule 8.42.
  - vii. The following wording shall be added to Part 2 of the Consolidation Order as Article 52A:

"Limited Waiting Monday – Saturday 8.00am-6.00pm waiting limited to 2 hours return prohibited within 4 hours (Schedule 8.42)

Save as provided in Articles 54 and 56 of this Order no person shall, except upon the direction or with the permission of a civil enforcement officer in uniform, cause or permit any vehicle to wait between the hours of 8.00am to 6.00pm Monday to Saturday in the lengths of road specified in Schedule 8.42 to this Order unless such day falls upon a Bank Holiday:

- (a) for a period longer than 2 hours or
- (b) if a period of less than 4 hours has elapsed since the termination of the last period of waiting (if any) by that vehicle on the same side or length of road"
- viii. In Article 56(b) of the Consolidation Order the reference to "Schedules 8.00 to 8.41" shall be replaced with a reference to "Schedules 8.00 to 8.42".
- ix. The items in Table G to this Variation Order are revoked from the Consolidation Order to the extent set out in Column 2 of that Table.
- 3. Except as hereinbefore provided in this Variation Order the provisions and articles of the Consolidation Order shall remain in force.
- 4. The provisions imposed by this Variation Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
