- I would like to see what evidence the Council has in respect of the above claim.
- The footpath in question was made by *Levi Pogson* of Woodend in 1845, when he held a lease for Severhills Mill. This *private* footpath was for his personal use in connection with his work at the aforementioned mill. (ref. *Halifax Antiquarian Society* 1934 - *Severhills Mill* page 39-40)
- Severhills Mills ceased operation in 1908 and since then the path has never been used.
- Severhills House has been in my family since 1904, my mother was born at Severhills. From my childhood to this day, nobody has ever used this path.
- The footbridge was washed away in the 1950s and has never been rebuilt.
- A Private Property sign has always been displayed at Severhills.
- Please note that I have served notice to the occupants of Woodend House and Woodend Barn, whose property this 'path' crosses.

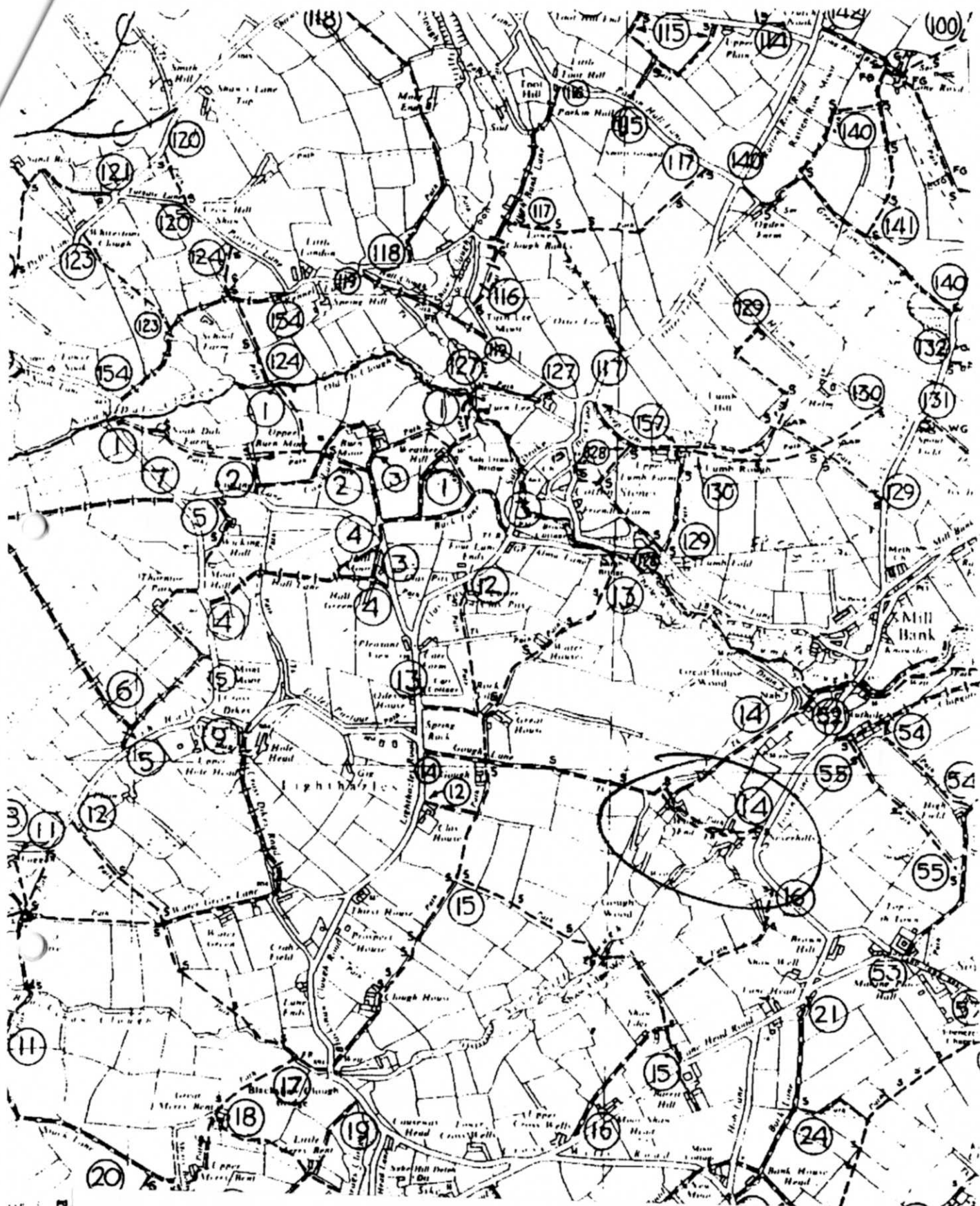
