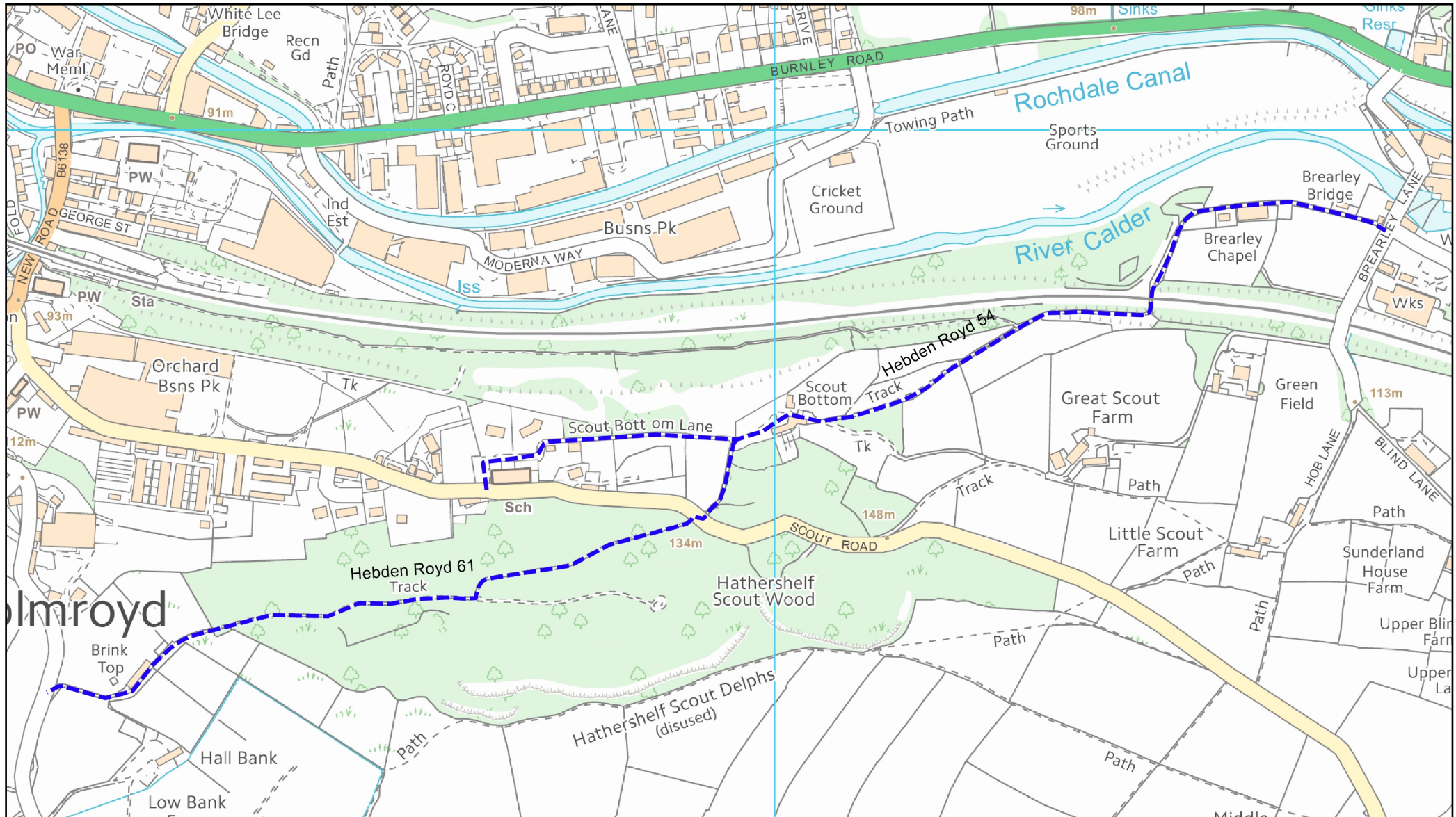
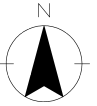

CMT8/15/356 5/23/B Thirty nine documents, mainly letter, referring to repairs to walls adjoining the road from Hob Lane to Scout Bottom, Brearley, most referring to this claimed route as 'road'.

One of these documents on 3 March 1944, published by Hebden Royd UDC, describes the claimed route officially as highway, not repairable by the local authority, used by the public travelling between Brearley and Scout Bottom, at which place children from Brearley attend school.

Minutes from Hebden Royd UDC, 1899-1906, which confirm how roads which were abutted by landowners' fields etc, were under the jurisdiction of the Council as they were for the use of the public.
