

**ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT (2014)**

**NOTICE OF INTENTION TO EXTEND THE DURATION OF EXISTING PUBLIC**  
**SPACES PROTECTION ORDERS RELATING TO MOORLAND AREAS;**  
**ALCOHOL CONSUMPTION IN PUBLIC PLACES; AND DOG CONTROL ORDERS**  
**ALL WITHIN THE BORDERS OF THE CALDERDALE BOROUGH COUNCIL**

1. Notice is hereby given that the Borough Council of Calderdale ("the Council") intends to extend the seven Public Spaces Protection Orders under Section 60 of the Anti-Social, Behaviour, Crime and Policing Act 2014 ("the Act") for a period of three years from until midnight the 16<sup>th</sup> of June 2025. **These Orders were made:**

- a. In the case of the Moorland Public Spaces Protection Order, on the 17<sup>th</sup> of June 2019
- b. In the case of the Dog Control Public Spaces Protection Orders, on the 21<sup>st</sup> of October 2020
- c. In the case of the Alcohol Consumption in Designated Places Public Spaces Protection Order, on the 21<sup>st</sup> of October 2020.

The seven Orders shall take effect until midnight of the 16<sup>th</sup> of June 2025 unless extended by further orders under the Council's statutory powers.

2. The Council is satisfied on reasonable grounds that extension is necessary to prevent:

- a. occurrence or recurrence of the activities identified in the order, and / or
- b. an increase in the frequency or seriousness of those activities after the expiry of the existing orders on the 16<sup>th</sup> of June 2022.

3. The Proposed Orders relates to Moorland Areas; Alcohol Consumption in Public Places; and all Dog Control Orders inside the borders of Calderdale as specified within each Order and Order Plan (The Restricted Area).
