#### **NOTICE OF INTENTION TO VARY A PUBLIC SPACES PROTECTION ORDERS RELATING TO**

- MOORLAND SPACES PROTECTION ORDER
- ALCOHOL CONSUMPTION IN DESIGNATED PUBLIC SPACES
- FOULING OF LAND BY DOGS ORDER

Notice is hereby given that Calderdale Borough Council ('the Council') proposes for the purpose of reducing antisocial behaviour in relation to the Public Spaces Protection Orders (above) under Section 61 of the Anti-Social Behaviour Crime and Policing Act 2014 and of all other enabling powers.

The Council would like to seek your views on the proposed Notice of Intention to vary these Orders. This Notice outlines the details of the proposed variations to the Orders

Proposed Variations -

#### **MOORLAND SPACES PROTECTION ORDER to include:**

The prohibition of

1. the use of motor vehicles without written permission of the landowner, save for those vehicles used by emergency services, vehicles used by other public bodies; or an authorised officer in pursuance of the Order.
2. any activity in preparedness of using a motor vehicle within the restricted area other than with written agreement of the landowner, save for those vehicles being used by the emergency services; other public bodies; or an authorised officer in pursuance of this Order.

The requirement for

1. a person or persons using a motor vehicle to produce a written notice from the landowner specifically allowing such activity on their land.
2. a person or persons using a motor vehicle must stop at the request of an authorised officer

The areas of land to which these variations apply are shown within the new 'draft' orders ('restricted areas').

**ALCOHOL CONSUMPTION IN DESIGNATED PUBLIC SPACES to include:**

The requirement for

The restricted area to be extended to include all areas of the borough.

The areas of land to which these variations apply are shown within the new 'draft' orders ('restricted areas').

**FOULING OF LAND BY DOGS ORDER**

The requirement for

Any person in charge of a dog, shall, upon request by an authorised officer, produce for that officer their means of being able to pick up their dog's excrement, even if the dog has not defecated at the time of the request.

The areas of land to which these variations apply are shown within the new 'draft' orders ('restricted areas').

The variations will come into force from the 17<sup>th</sup> of June 2022 and will last for up to 3 years. Any comments and/or objections should be sent in writing or by email to the correspondence address below.

At the closure of the formal consultation period, Calderdale Borough Council will review all comments/objections and will make a decision on whether to vary the order or an alternative in part or in full.
