Environment Act 1995- Section 83(1) The Borough Council of Calderdale Calderdale Air Quality Management Area (No.6) Order

Calderdale Metropolitan Borough Council, in exercise of the powers conferred upon it by Section 83(1) of the Environment Act 1995, hereby makes the following Order.

This Order may be cited as the Calderdale Air Quality Management Area (No. 6) Order and shall come into effect on 1st August 2007.

The area on the attached map within the boundary shown in black, which extends from the A6025 Elland Road, Brighouse in the west, to the A644 Wakefield Road, Brighouse in the east; and from the A644 Halifax Road Brighouse and the A641 Bradford Road, Brighouse in the north, to the A643 Bramston Street, Brighouse, and Mill Royd Street, Brighouse in the south; and which is described in the Schedule below, is to be designated as an Air Quality Management Area (the designated area). The map is attached to and forms part of this Order. This Order, schedule and map may be viewed at Environmental Health Services, Calderdale MBC, Northgate House, Northgate, Halifax HX1 1UN.

This area is designated in relation to a likely breach of the nitrogen dioxide (annual mean) objective, as specified in the Air Quality (England) Regulations 2000.
