

Street Trading Guidance

Consent streets

A consent street is where street trading is permitted on an occasional basis with a daily fee, only with the consent of Calderdale Council and the issue of a licence to undertake street trading, which must be displayed at all times.

Halifax

- 1. Full streets: Bull Green, George Square, George Street, The Square and Woolshops
- 2. Sections of streets: Commercial Street (St. John's Lane to Alexandra Street), Crown Street (junction with Waterhouse Street to area adjacent to No37) Wade Street (Northgate to Winding Road) and Wards End (Commercial Street to Horton Street)

Brighouse

Canal Street

Area next to the market along the canal bank (from Canal Street to car park).

Licensed streets

A licence to trade is where trading is permitted in a designated area with an annual, monthly or weekly fee, only with the consent of Calderdale Council and the issue of a licence to undertake street trading, which must be displayed at all times.

Note: Day-time trading shall only take place between the hours of 08.00 and 18.00 (Monday to Sunday inclusive). Night-time trading shall only take place between the hours of 19.00 and 03.00 (Monday to Sunday inclusive).

Food hawkers should note that they are required to register both themselves and any premises they may use for the storage of food intended for sale, with Environmental Health, Northgate House, Northgate, Halifax, HX1 1UN, 01422 392373.

All food hawkers keeping their vehicles overnight within the Borough of Calderdale must register with Environmental Health.

Hawkers operating outside the Borough must register with their own Local Authority and provide proof of registration.

All Hawkers must register with the Local Authority at least 28 days prior to trading.

Any vehicle/stall that provides late night refreshment will need to hold a Premises Licence. Late night refreshment means the supply of hot food or hot drink to the public between 11.00pm and 5.00am. You will need to contact the Licensing Unit to apply for this licence.

If your consent or licence is for the Woolshops area in Halifax please contact them prior to your application on 01422 345277. Please note the application may be subject to a charge.


2. Sections of streets

Bowling Dyke (from North Bridge Street to Jemmy Lane), Charlestown Road (from New Bank for a distance of 375 metres southwards), Commercial Street (from Alexandra Street to Crown Street), Cross Hills (from Northgate of Burdock Way Flyover), Cross Street (Winding Road to Foundry Street), Cross Street (Horton Street to Piece Hall), King Cross Street (from Bull Green to Hanover Street), Lily Lane (footpath) (School Street to east side of subway under railway), Lister Lane (Cow Green to Bridge over Burdock Way), Paradise Street (Henry Street to High Street), Paradise Street (from Delph Street for 25 metres southwest), Pellon Lane (Cow Green to Bridge over Burdock Way), Skircoat Road (Prescott Street to Oxford Road), Stead Street (Lister Lane to Mount Street), Stead Street (Gibbet Street for 10 metres south), Trinity Street (from St John's Lane for 87 metres northwards), Trinity Street (Trinity Road to Carlton Terrace), Wade Street (from Winding Road to Mulcture Hall Road) and Wards End (from Horton Street to Southgate).




Location of Licensed Streets (Halifax)
