PROPOSALS – POLLING DISTRICT, PLACES AND STATIONS REVIEW 2023

RECOMMENDATIONS OF THE (ACTING) RETURNING OFFICER

All polling districts, polling places and polling stations have been considered in the preparation of this report. The changes referred to below require action due to the closure of many buildings. In reviewing all places, consideration has been given to the Boundary Commission for England's recent review of UK parliamentary constituencies, as well as the Local Government Boundary Commission for England's (LGBCE) ongoing Electoral Review of Calderdale Council. In an effort to avoid confusion, it is not considered useful to voters, future candidates and other electoral stakeholders if further changes are implemented ahead of the completion of the LGBCE's Electoral Review as it is anticipated that substantial changes may be made with the potential addition of a Ward and possible moving of most Ward boundaries.

Where electoral arrangements are affected by this Review a note highlighting any changes on Poll Cards sent at the time of elections, and Poll Cards will include maps as usual.

The (Acting) Returning Officer is entitled to use any publicly funded building (including schools) where it has not been possible to find alternative premises.

For information – The Boundary Commission for England has concluded that there will be a change to the parliamentary constituency boundaries between Halifax and Calder Valley.

Polling Districts MB – Sowerby, MC – White Windows and MD – Triangle will move from the Calder Valley Constituency into the Halifax Constituency (but remain in the Ryburn Ward). All households in these polling districts will be notified of changes to electoral arrangements.
