

THE BOROUGH COUNCIL OF CALDERDALE (ON-STREET WAITING, LOADING AND PARKING PLACES) (WESTERN CORRIDOR) AMENDMENT NO.01 ORDER 2024

The Borough Council of Calderdale in exercise of its powers under Sections 1, 2, 3, 4, 19, 45, 46, 47, 49, 51, 53, 65(1) and 124 under the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order, The Borough Council of Calderdale (On-Street Waiting, Loading and Parking) Consolidation Order 2024 (as amended) (To be known as ‘The 2024 Consolidation Order’) shall have effect as though;
 - (i) The Map Tiles set out in Schedule 1 to this Order will be revoked and replaced with the Map Tiles as set out in Schedule 2 to this Order.
 - (ii) The 2024 Consolidation Order is amended by the revocation of the table for Tariff Band P in Schedule 2 of the 2024 Consolidation Order.
 - (iii) The table for Tariff Band C as set out in Schedule 3 to this Order shall replace the table for Tariff Band C in Schedule 2 of the 2024 Consolidation Order.
 - (iv) The plans set out in Schedule 4 to this Order will replace the corresponding plans in Schedule 4 to the 2024 Consolidation Order.
2. The effect of this Order is to (this article is an explanatory note this is not part of the Order):
 - a) The Map Tiles to The Consolidation Order 2024 shall be amended to reflect the changes listed in Table 1.
