THE BOROUGH COUNCIL OF CALDERDALE

The Dogs (Specified Maximum) (Calderdale) Public Space Protection Order 2022

The Borough Council of Calderdale (in this Order called “the Authority”) hereby makes the following Order:

1. This Order comes into force at 00:01 hours on Friday 17th June 2022, and shall have effect until midnight on 16th June 2025, unless extended by further orders under the Council’s statutory powers.
2. The Authority is satisfied that the following activities are taking place within the restricted area:
 - incidents and concerns from the public arising from irresponsible dog ownership and poor dog control
3. The Authority is further satisfied that the activities referred to in paragraph 2 above are having or are likely to have a detrimental effect on the quality of life of those in the locality and it therefore makes a Public Spaces Protection Order, the terms of which are explained below.

Restricted Area

4. Unless otherwise stated, the prohibitions and requirements detailed below shall apply at all times of the day and all days of the week throughout any calendar year throughout the entirety of the restricted area shown in the schedule.

Maximum Dog Prohibition

5. (1) All persons are prohibited from being in charge of more than 6 dogs on any land within the Restricted Area unless –
 - (a) he has a reasonable excuse for doing so; or
 - (b) the owner, occupier, or other person or authority having control of the land has consented (generally or specifically) to his doing so.
- (2) For the purposes of this paragraph a person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at the time some other person is in charge of the dog.

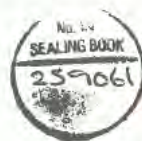
Penalty

6. A person who is guilty of an offence under paragraph 5 shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.
