- Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Variation Order, the Borough Council of Calderdale (On-Street Waiting, Loading and Parking) Consolidation Order 2024 ("the Consolidation Order") shall have effect as though;
 - (i) The Plans so numbered set out in Schedule 1 to this Variation Order will be revoked and replaced with the Plans so numbered as set out in Schedule 2 to this Variation Order.
 - (ii) The table for Tariff Band L as set out in Schedule 3 to this Order shall replace the table for Tariff Band L in Schedule 2 of the 2024 Consolidation Order.
 - (iii) The table for Tariff Band Q as set out in Schedule 4 to this Order shall be added to Schedule 2 of the 2024 Consolidation Order.
 - (iv) The Plans set out in Schedule 5 to this Order will replace the corresponding Plans in Schedule 4 to the Consolidation Order.
