(WAINSTALLS SCHOOL) (TREE LANE) TRAFFIC REGULATION ORDER 2025

The Borough Council of Calderdale in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

PART 1

GENERAL

Citation and commencement

 This Order is made on the 30th day of April 2025 and shall be cited as "The Borough Council of Calderdale (Wainstalls School) (Tree Lane) Traffic Regulation Order 2025" and shall come into force on 5 May 2025.

Interpretation

- 2. The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
- Where a provision of this Order is in conflict with a provision contained in a previous Order, the provisions of this Order shall prevail for the period that this Order is in force.
- 4. Where a statute, statutory instrument, specification or regulation is referred to such reference shall include an amendment to or replacement thereof.
- 5. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction, regulation or other requirement imposed by law.

Definitions

- 6. In this Order, the following expressions have the meaning hereby respectively assigned to them:-
 - "Vehicle" has the same meaning as that in Section 136 of the Road Traffic Regulation Act 1984;

"Road" has the same meaning as that in Section 142 of the Road Traffic Regulation Act 1984;

PART 2 MOVING TRAFFIC

One Way Traffic Flow

- 7. Save as provided in Articles 8 and 9 of this Order, no person shall except upon the direction or with the permission of a police officer in uniform cause any vehicle to proceed in the length of Road specified in Column 1 of Schedule 1 to this Order to the extent specified in Column 2 in a direction other than that specified in relation to such Road in Column 3 of the said Schedule.
- 8. Nothing in Article 7 of this Order shall apply to any Vehicle being used for police, fire brigade or ambulance purposes when being used in an emergency.
- 9. Nothing in Article 7 of this Order shall apply to any mechanical road cleansing vehicles when being used for that purpose.
