The Dogs Exclusion (Calderdale) Public Space Protection Order 2025

The Borough Council of Calderdale (in this Order called "the Authority") hereby makes the following Order:

- This Order comes into force at 00:01 hours on Tuesday 17th June 2025, and shall effect until midnight 17th June 2028, unless extended by further orders under the Council's statutory powers.
- 2. The Authority is satisfied that the following activities are taking place within the restricted area:
 - incidents and concerns from the public arising from irresponsible dog ownership and poor dog control
- 3. The Authority is further satisfied that the activities referred to in paragraph 3 above are having or are likely to have a detrimental effect on the quality of life of those in the locality and it therefore makes a Public Spaces Protection Order, the terms of which are explained below.

Restricted Area

4. Unless otherwise stated, the prohibitions and requirements detailed below shall apply at all times of the day and all days of the week throughout any calendar year throughout the entirety of the restricted area shown in the schedule.

Dog Exclusion/Prohibition

- 5. (1) All persons are prohibited from either taking or permitting a dog to enter (or to remain on) any land within the Restricted Area unless
 - (a) They have a reasonable excuse for doing so or;
 - (b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to them doing so.
 - (2) Nothing in this paragraph applies to a person who -
 - (a) is registered as a blind person in a register complied under section 29 of the National Assistance Act 1948; or
 - (b) is deaf, in respect of a dog trained by Hearing Dogs for Deaf People (registered charity number 293358) and upon which he relies for assistance; or
 - (c) has a disability which affects his mobility, manual dexterity, physical co-ordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which they rely on for assistance.
 - (3) For the purposes of this paragraph -
 - (a) a person who habitually has a dog in their possession shall be taken to be in charge of the dog at any time unless at the time some other person is in charge of the dog; and
 - (b) each of the following is a "prescribed charity" -
 - (i) Dogs for the Disabled (registered charity number 700454)
 - (ii) Support Dogs (registered charity number 1088281)
 - (iii) Canine Partners for Independence (registered charity number 803680)

Penalty

6. A person who is guilty of an offence under paragraph 5 shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.
