THE Scheme and Orders have been made by the Borough Council of Calderdale under the above-mentioned Acts and submitted to the Secretary of State for Transport for confirmation and are:

(1) THE BOROUGH COUNCIL OF CALDERDALE (ELLAND STATION AND WEST VALE ACCESS PACKAGE) (WEST YORKSHIRE PLUS TRANSPORT FUND, TRANSFORMING CITIES FUND) (CALDER AND HEBBLE NAVIGATION BRIDGE) SCHEME 2022. This is a Scheme under Section 106(3) of the Highways Act 1980.

(2) THE BOROUGH COUNCIL OF CALDERDALE (ELLAND STATION AND WEST VALE ACCESS PACKAGE) (WEST YORKSHIRE PLUS TRANSPORT FUND, TRANSFORMING CITIES FUND) (SIDE ROADS) ORDER 2022. This is an Order under Sections 14 and 125 of the Highways Act 1980.

(3) THE BOROUGH COUNCIL OF CALDERDALE (ELLAND STATION AND WEST VALE ACCESS PACKAGE) (WEST YORKSHIRE PLUS TRANSPORT FUND, TRANSFORMING CITIES FUND) COMPULSORY PURCHASE ORDER 2022. This is an Order under Sections 239, 240, 250 and 260 of the Highways Act 1980.

The Scheme and Orders relate to the Elland Access Package Scheme which includes the improvement of the A6112 Stainland Road, A6025 Park Road, Eastgate, Wistons Lane and Gas Works Lane and the construction of new highways including the construction of two new bridged canal and river crossings at Elland and West Vale.
