1. Apologies

3. Previous Minutes

ETM reported that the minutes from the 26 March 2025 and 18 June 2025 meetings have been published on the website.

4. Orders for Consideration

a) Parking Strategy and Charges Review - Extension of parking charges, Halifax (TRO)

Following on from the Cabinet decision to progress these works on 4 November 2024, work has been progressing. Most of the work agreed has been completed, this Traffic Regulation Order change is the remaining section.

OO explained that this proposal is to change the times that the pay and display charges apply on King Street, Cripplegate and Mulcture Hall Road, Halifax (see drawing 2 below). Currently, parking charges are in place Monday – Saturday, 8:00am – 6:00pm at these locations. Halifax town centre is affected by regeneration work and car park closures, resulting in these spaces seeing an increasing demand for parking. It is proposed that by extending the charging days and hours to Monday – Sunday, 8:00am – 8:00pm (Inc Bank Holidays) will encourage both the improved turnover of available spaces, and consideration to using alternative modes of travel.

This proposal has been informally consulted with affected Ward Councillors and emergency services etc. One objection was received from one Ward Councillor; however, this was later withdrawn after it had been clarified that this proposal had been previously approved by Cabinet.

MINUTES OF TRO GOVERNING BODY MEETING – 13 August 2025

The GB discussed these proposals and voted on whether the scheme should progress to the next and wider stage of consultation.

Outcome

It was unanimously agreed (by CL(DAM), CL(T) and TE) that all the proposal can proceed to the statutory consultation.

The TROGB:




