NOTIFICATION OF VARIATION OF HACKNEY CARRIAGE FARES

NOTICE IS HEREBY GIVEN by the Borough Council of Calderdale in accordance with Section 65 of the Local Government (Miscellaneous Provisions) Act 1976 that the fare charges for the hire of hackney carriages licensed to ply for hire in the following areas of the Metropolitan Borough of Calderdale: -

the former Borough of Brighouse
the former Urban District of Elland
the former County Borough of Halifax
the former Urban District of Hebden Royd
the former Urban District of Queensbury and Shelf (part)
the former Urban District of Sowerby Bridge
the former Borough of Todmorden
the former Urban District of Ripponden
the former Rural District of Hepton

are to be varied to the following: -

As proposed by the Hackney Carriage Association

Tariff 1 (Day time rate from 06.00 a.m. to 11.00 p.m.)

- (a) For the first 621 metres (679 Yards)..... Currently £2.80 – Proposed £3.50
(20% increase)
- (b) For each subsequent 73 metres (80 Yards) or part thereof.....£0.10

Tariff 2 (Night time rate from 11.00 p.m. to 06.00 a.m.)

- (a) For the first 460 metres (503 Yards)..... Currently £2.90 – Proposed £3.70
(24.3% increase)
- (b) For each subsequent 63 metres (69 Yards) or part thereof.....£0.10

Tariffs 1 and 2

Waiting time – for each period of 36 seconds or part thereof.....£0.21

Tariff 3 (Day time rate from 06.00 a.m. to 11.00 p.m.)

Where 5 or more passengers are carriedTariff 1 fare + half the meter fare

Tariff 4 (Night time rate from 11.00 p.m. to 06.00 a.m.)

Where 5 or more passengers are carriedTariff 2 fare + half the meter fare

Extra Charges

- (a) For each article of luggage or pram conveyed in the luggage compartment (max. charge 50p)£0.10
- (b) For each person in excess of two£0.10
- (c) For hirings commenced from 6.00 p.m. December 24th through to 6.00 a.m. December 27th.....Tariff 2/Tariff 4 rates will apply
- (d) For hirings commenced from 6.00 p.m. December 31st through to 6.00 a.m. January 2nd.....Tariff 2/Tariff 4 rates will apply
- (e) Soiling charge.....£25.00
- (f) For hirings commenced on Bank Holidays 6.00am through to 6.00am the next day Tariff2/Tariff4 will apply.

The above variation will become operative on 16 December 2025 unless any objection is made to the variation within fourteen days from the date of this notice. Any objections received will be considered and the variation will be approved, with or without modification, in accordance with the provisions of the Local Government (Miscellaneous Provisions) Act 1976.
