



NOTICE OF VARIATION OF PARKING CHARGES

The Borough Council of Calderdale (Car Parks) (Consolidation) Order 2019 **Notice of Variation (No. 6 2026)**

NOTICE IS HEREBY GIVEN that the Borough Council of Calderdale, in exercise of its powers under Section 35C of the Road Traffic Regulation Act 1984 and Regulation 25 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and of all other enabling powers, shall vary the tariffs for off-street parking charges in the following car parks in Brighouse.

This notice will vary the tariffs set out in Schedule 1 to the Borough Council of Calderdale (Car Parks) (Consolidation) Order 2019 (as amended) ("the Order"). The existing tariffs and the new tariffs are listed below. In all other respects, the Order will remain unchanged. The changes will come into force on Sunday 15th February 2026.

Variation of tariff in relation to Bethel Street Car Park in Brighouse:

Variation of tariff in relation to Parsonage Lane Car Park in Brighouse:

Variation of tariff in relation to Owler Ings Car Park, Daisy Street Car Park and Commercial Street Car Park in Brighouse:

Monday – Saturday 8am – 6pm £0.70 per hour	Monday – Saturday 8am – 6pm £1.00 per hour Capped at £7.00

Variation of tariff in relation to Mill Lane Car Park and Bank Street Car Park in Brighouse:

Existing Tariff	New Tariff
Monday – Saturday 8am – 6pm £0.50 per hour Capped at £3.50	Monday – Saturday 8am – 6pm £0.60 per hour Capped at £4.00

Variation of tariff in relation to Church Lane Car Park in Brighouse:

Existing Tariff	New Tariff
Monday – Saturday 8am – 6pm First hour free £0.50 per hour Capped at £3.00	Monday – Saturday 8am – 6pm First hour free £0.60 per hour Capped at £4.00
